- 3. It is a condition of bidding that a vendor's taxes must be in order, or a satisfactory arrangement must have been made with the Receiver of Revenue to meet his/her tax obligation. Where consortia /joint venture/subcontractors are involved, each party must submit a separate Tax Clearance Certificate.
- 4. Please note that the services in the database are classified as commodities and each potential vendor must indicate the commodity/ commodities in which it would like to apply for RFQs.
- 5. It is important for any applicant to note that the successful registration on the SFH-SA supplier database does not guarantee the applicant any business opportunities.
