

The Impumelelo B-BBEE Codes of Good Practice Conference - Siyavaya!

The B-BBEE Codes of Good Practice is said to be the most important piece of legislation to influence South African business in the last century.

The Department of Trade and Industry (dti) is proud to be in partnership with Top Companies Publishing and Events in hosting the Impumelelo B-BBEE Codes of Good Practice Conference. Said the dti in their support letter of the event, "This conference, which is indeed timely and relevant for the market, will contribute in enhancing understanding on the Codes of Good Practice and show how charters and legislation is harmonized as well as provide further clarification on B-B-BBEE.
